2003-2004 Kindergarten Immunization Assessment Results

The California Department of Health Services Immunization Branch and local health departments conduct school assessments each fall to monitor compliance with California school immunization law. Assessments are performed at licensed childcare/Head Start centers, kindergartens, and seventh grade schools. Each September, assessment forms are sent out to California schools and childcare centers for completion by school staff.

This year's kindergarten immunization assessment results show that 92.5% of the 513,519 children enrolled in reporting kindergartens received all required immunizations mandated by school law for the corresponding school year (3+ Polio, 4+ DTP, 2+ MMR, 3+ Hep B, and 1+ varicella). Results are presented in Table 1.

This year, the percent of children with personal beliefs exemptions (PBEs) or permanent medical exemptions (PMEs) are 1.16% and 0.13%, respectively, similar to last year. A trend graph showing PBE and PME rates since 1996 is presented in Figure 1. The coverage level for the varicella requirement (proof of immunization or physician-documented disease), 97.3% this year, continues to edge upward. This is particularly impressive given that varicella has only been a requirement since 2001. All single antigen coverage levels surpass the Healthy People 2010 goal of 90% coverage. The lowest antigen coverage continues to be for the fourth dose of DTP (95.2%).
