

2004-05 CHILD CARE ASSESSMENT RESULTS
CALIFORNIA DEPARTMENT OF HEALTH SERVICES, IMMUNIZATION BRANCH

Introduction

The annual child care assessment is conducted each fall to monitor compliance with the California School Immunization Law. Results from this assessment are used to measure immunization coverage among children ages 2 years-4 years, 11 months. This report presents results from this year's child care assessment and the attached tables present comparisons of immunization coverage in child care facilities by county.

Methods and Participants

This year's child care assessment was conducted in 9,925 of California's licensed child care facilities. Child care facility staff complete assessment reports and send them to local health departments. Data are summarized by local health department staff and reported to the Immunization Branch. Please note that the child care assessment is conducted in licensed child care facilities and therefore, estimates of immunization coverage apply only to children enrolled in licensed child care.

Results and Discussion

Results from the fall 2004 child care assessment are similar to previous years (Table 1). This year 93.7% of the 487,738 children enrolled in reporting child care facilities received all required immunizations (4+ DTP, 3+ Polio, 1+ MMR, 1+ Hib, 3+ Hep B, and 1+ varicella). There were 6,132 (1.26%) children with personal belief exemptions and 1,038 (0.21%) children with permanent medical exemptions. Immunization coverage for each vaccine was higher than 96%. Varicella was introduced as an immunization requirement in 2001. Immunization coverage for this vaccine has shown improvement, from 93.3% in 2001 to 96.6% in 2004.
