

2011-2012 CHILD CARE ASSESSMENT RESULTS
CALIFORNIA DEPARTMENT OF PUBLIC HEALTH, IMMUNIZATION BRANCH

Introduction

The annual child care assessment is conducted each fall to monitor compliance with the California School Immunization Law. Results from this assessment are used to measure immunization coverage among children entering licensed child care. This report presents results from this year's child care assessment and the attached tables present comparisons of immunization coverage in child care facilities by county.

Methods and Participants

This year's child care assessment was conducted in 10,042 of California's licensed child care facilities. Child care facility staff complete assessment reports and send them to local health departments. Data are summarized by local health departments and reported to the Immunization Branch. The age group assessed is 2 years to 4 years, 11 months. Roughly one-third of children in this age group attend licensed child care centers. The following data are only for children in licensed child care centers and may not be representative of the entire population of California children in this age group.

Results and Discussion

A summary of results from the fall 2011 child care assessment are found below. (Table 1). This year 89.5% of the 517,745 children enrolled in reporting child care facilities received all required immunizations (4+ DTP, 3+ Polio, 1+ MMR, 1+ Hib, 3+ Hep B, and 1+ Var or physician-documented varicella disease). There were 1,131 (0.22%) children with permanent medical exemptions and 13,450 (2.60%) children with personal belief exemptions. Immunization coverage was above 94% for each vaccine.
