

2014-2015 CHILD CARE IMMUNIZATION ASSESSMENT RESULTS
CALIFORNIA DEPARTMENT OF PUBLIC HEALTH, IMMUNIZATION BRANCH

Introduction

The annual child care assessment is conducted each fall to monitor compliance with the California School Immunization Law. Results from this assessment are used to measure immunization coverage among children entering licensed child care facilities. Under Assembly Bill 2109 (2012), California Health and Safety Code Section 120335 modified the process of obtaining a personal beliefs exemption (PBE) to immunization and requires documentation that health care practitioners have informed parents about vaccines and diseases. A religious exemption option was added when the bill was signed. This report summarizes the assessment of child care immunization requirements based on reporting from California child care facilities. The attached tables present immunization rates by county.

Methods and Participants

This year's child care assessment was conducted in 9,271 of 10,537 (88%, Table 2) California's licensed child care facilities. Child care facility staff completed assessment reports and submitted them to local health departments and the Immunization Branch. The age group assessed is 2 years to 4 years, 11 months. Roughly one-third of children in this age group attend licensed child care facilities. The following data are only for children in licensed child care facilities that have reported and may not be representative of the entire population of California children in this age group. Changes to this year's report include several new PBE measures. Pursuant to the new PBE law, in addition to the standard PBE totals measure, children with PBEs were placed into one of three new PBE subcategories (see Tables 1, 4, and 5): 1) children who enrolled in child care prior to January 2014 ('pre-Jan PBE'), 2) children whose parents received documented vaccine counseling from a qualified health care practitioner with the last 6 months ('Health Care Practitioner Counseled' PBE), or 3) children whose parents declared an objection to seeking medical advice or treatment from authorized health care practitioners ('Religious' PBE).

Results and Discussion

Table 1 shows the results from this fall's child care assessment for the state as a whole and by facility type. This year, 89.4% of the 434,922 children 2 years to 4 years 11 months of age enrolled in reporting child care facilities received all required immunizations (4+ DTP, 3+ Polio, 1+ MMR, 1+ Hib, 3+ Hep B, and 1+ Vari or physician-documented varicella disease), a 0.1% increase from the prior year. 'Conditional' entrants, defined as children in process to be fully vaccinated but not yet having all required vaccinations, decreased by 0.1% this past year. There were 2,734 (0.56%) children with permanent medical exemptions (PMEs) and 12,981 (2.67%) with personal beliefs exemptions. Children with personal beliefs exemptions decreased from 2.94% to 2.67% this past year (0.27% reduction, Table 1 and 4, Figure 10). For all facilities, immunization coverage was greater than or equal to 94% for each vaccine this year.

*Individual antigen status is unavailable for children with Personal Beliefs Exemptions. Therefore, individual antigen immunization coverage may be underestimated; anecdotal evidence suggests a small percentage of children may have some but not all required immunizations.

**Conditional Entrant is a student who does not meet all requirements. This student must be followed up because he/she: lacks (i.e., is not yet due for) at least one dose and does not have a personal beliefs or permanent medical exemption; or has a physician affidavit of Temporary Medical Exemption for one or more doses; or is a transfer student who has no record available yet.




Figure 2: Percentage of California Child Care Enrollees Completing Required Vaccine Series by Facility Type




Figure 3: Percentage of Conditional Entrants Among California Child Care Enrollees by Facility Type




Figure 4: Percentage of Child Care Enrollees in California with Permanent Medical Exemptions by Facility Type




Figure 5: Percentage of Child Care Enrollees in California with a Personal Beliefs Exemption by Facility Type




Figure 6: Percentage of Child Care Enrollees in California with a Health Care Practitioner Or Religious Exemption by Facility Type

The percentage of children receiving required vaccines and exemptions differed depending on facility type (Table 1). Among the three child care facility types, Head Start Facilities reported the highest percentage of children having received all required immunizations (Figure 1 and 2), and the lowest percentage of 'Conditional' entrants (2.9%, Figure 3) and children with medical (0.15%) or personal beliefs exemptions (0.63%, Figure 4 and 5). Private facilities reported the highest percentage of 'Conditional' entrants (8.6%, Figure 3) and children with medical (0.34%, Figure 4) or personal beliefs exemptions (4.11%, Figure 5) compared with other facility types. Compared to last year, the percentage of PBE children in Head Start facilities was 0.48% lower, 0.43% lower in private facilities, but 0.25% higher in public facilities in 2014-15 (Table 1 and Figure 10). Of the new PBEs taken in 2014-15, the majority of children took a 'Counseled' Exemption (76%) compared with a 'Religious' Exemption (24%, Figure 6). This approximately 3 to 1 ratio of 'Counseled' to 'Religious' PBEs was similar in both public and private facilities, but contrasted with Head Start facilities where 'Religious' exemptions were in the majority compared to 'Counseled' exemptions (0.13% vs. 0.09%, Table 1).

Figure 1: Percentage of California Child Care Enrollees with All Required Immunizations by Facility Type




Figure 7: Percentage of California Child Care Enrollees Completing All Required Immunizations By Facility Type, 2010-11 to 2014-15 School Years




Figure 8: Percentage of Conditional Entrants Among California Child Care Enrollees By Facility Type, 2010-11 to 2014-15 School Years






Figure 9: Percentage of California Child Care Enrollees with a Permanent Medical Exemption By Facility Type, 2010-11 to 2014-15 School Years


Figure 10: Percentage of California Child Care Enrollees with a Personal Beliefs Exemption By Facility Type, 2010-11 to 2014-15 School Years

PBE rates among child care enrollees in 2014-15 declined for the first time in many years (Figure 10), possibly in part due to the new PBE requirements introduced in Jan 2014. Overall PBE rates in child care facilities decreased by 0.27% in 2014-15. This represents a 9% reduction in overall PBE rates (2.94% to 2.67%), a 76% reduction in PBE rates at head start facilities (0.63% to 0.15%), a 10% reduction in PBE rates at private child care facilities (4.11% to 3.68%), but an 18% increase in PBE rates at public child care facilities (1.37% to 1.62%) when compared to PBE rates in 2013-14.

Of the different vaccine series, Hib had the highest completion rate (96.7%) among child care enrollees while DTaP had the lowest completion rate (93.8%, Table 1, Figure 11). And for the first time in several years, the

completion rate for all vaccines improved: Varicella was up 0.5%; DTP, MMR and Hepatitis B were up +0.4%; Hib was up +0.3%; and Polio was up +0.2%.
